- I. Call to Order

  - b. Wungsirivesh noted the audit will be completed by the end of May 2018. Financial were submitted for the record.
- V. President's Report:

Hageman noted the following improvements made around the condo.

  - Replaced plastic fences on 8 units.
  - Replaced remaining post lamps.
  - Removed and replaced shrubs
  - Trimmed trees
  - Cleared ravine
  - Hageman thanked landscape committee for all of their work.
  - 3 water leaks were repaired
  - Installed new street signs.
  - Started the multi-year project to replace meter packs (~\$32,000 in 2018)
  - ~\$8000 of asphalt repairs
  - ~\$17,000 concrete repairs

- The Board had a Reserves study conducted in which the company went into 5-6 units (different types) and walked the community to project the needed future maintenance that would be needed and the estimated cost. The board will use this information when determining future budgets and reserve requirements. The Company that performed the reserve study, said the association is well maintained. The provided a positive report and gave the board info on where we needed to start putting money aside for future project.

Hageman noted the following projects for 2019:

- Replace plastic fences
- 4 buildings will have new meter packs installed.
- Tree trim.
- Continued improvement around landscape.
- Continued asphalt and concrete repairs scheduled.
