- I. Call to Order at 7:00 PM
- II. Approval of Minutes
  - a. Mastriani motioned to approve June 20, 2019 minutes and it was seconded by Wungsirivesh. Motion passed.
- III. Treasurer's Report
  - a. Wungsirivesh presented the financials as of July 31, 2019
    - i. Checking \$174,981.79
    - ii. Reserve Accounts:
      - 1. First Financial Bank Money Market \$226,555.11
      - 2. Prepaid Insurance \$13,733.00
    - iii. Total Assets \$415,269.90
    - iv. Increase in Reserve \$23,075.85
    - v. Total Owner's Reserve \$415,269.90
- IV. Manager's Report (Mauk)
  - a. Financials (July 2019)
    - i. Income has a positive variance of \$2,459.10.
    - ii. Administrative expense has a positive variance of \$4,954.74.
    - iii. Maintenance and repair expense has a positive variance of \$17,159.71.
    - iv. Utilities are under budget \$6,848.76.
    - v. Increase in reserve was \$23,075.85 after capital expenditures. Total assets are \$415,269.90

- VI. New Business
  - a. 4758 B Middletowne New Patio Door
    - i. Mastriani motion to approve patio door with approved color. Motion seconded by Holevas. Motion passed.
  - b. 655 H Providence Landscape Alterations
    - i. Tabled to allow board to view property.
  - c. Concrete Bid for leveling \$2,434.50

- i. Mauk noted that Doug walked with contractor for concrete leveling. B-Level submitted a bid of \$2,434.50. The Providence / Middletowne courtyard sidewalks are not candidates and not part of the bid.
  - 1. Wungsirivesh motioned to approve B-Level to level concrete across the property for \$2,434.50. Mastriani seconded motion. Motion passed.
- ii. Hageman has noted that we received a bid to replace the concrete and fix the trip hazard in the Providence / Middletowne Courtyard.
  - Wungsirivesh motioned to approved bid from Heiberger to replace the sidewalk in the Providence / Middletowne Courtyard for \$6,240. Mastriani seconded motion. Motion passed.
