POOL RULES AND SAFETY

Summer marks a favorite time with residents - spending relaxing days at the pool. The Board would like to review the following rules and regulations:

POOL HOURS: 8:00 a.m. - Dusk, 7 days a week

POOL KEYS

Pool users must be issued a special key for entry into the pool area. This key also opens the tennis courts, the door into the lower level of the lodge, as well as the exercise room. The key is the responsibility of the unit owner and must be signed for by the unit owner. If the key is lost, it can be replaced by the management company for a \$100.00 fee payable to the Association.

Residents should not attach key lock boxes to the pool fence. They will be removed.

RULES and REGULATIONS

- ABSOLUTELY NO DIVING. The pool is 6 feet deep at the waterfall end.
- NO GLASS BOTTLES OF ANY KIND IN THE POOL AREA. This is critical

 if a bottle gets broken anywhere near the pool, the pool will need to
 be drained, cleaned and refilled. This means the pool will be closed for
 an extended period of time and the cost is exorbitant. If the breakage is
 traced back to a specific unit, that owner will be assessed the cost of this
 procedure.
- Guests must be accompanied by a resident/unit owner at all times.
- Children under the age of fourteen (14) years must be accompanied by an adult at all times.
- Children cannot be left unattended.
- Running, roller blading and/or horseplay are not permitted in the pool area.
- Please be considerate of others and keep your music and conversation at a low and reasonable level.
- No food is allowed in the swimming pool.

POOL GUESTS

Guests are limited to six (6) per unit. You must accompany your guests at all times when they are in the pool area. Do not give your key to your guest. Failure to comply will result in a fine.

SAFETY EQUIPMENT

Backboards, rings, hooks, ropes, etc., are provided as required by law and are for your safety and protection, not for use as toys.

An emergency phone is provided for your use; it is only to be used in an emergency and is preprogrammed to call 9-1-1.

THE POOL IS A COMMUNITY AMENITY AND EACH RESIDENT AND GUEST SHOULD USE THE POOL IN A RESPECTFUL AND RESPONSIBLE MANNER.

Landscaping Guidelines: Maintaining Your Garden in a Community Setting

Gardening in a community setting is a bit different than at a stand alone home. Below are some reminders from the Policy Handbook:

- If you would like to maintain the landscape area adjacent to your unit, you should request a red stake from the Board via an Exterior Change Form with a description of your plans.
- Common areas are not permitted to be planted by individual owners
- · You are responsible for the maintenance of your garden areas if you choose to do so. This includes weeding and pruning.
- Growing fruits and vegetables in anything other than pots inside your patio is not permitted
- If you do not maintain your area, red stake privileges will be revoked. The decision to revoke red stake privileges shall be in the complete discretion of the Board.
- The area inside your patio is your responsibility. If this area is not taken care of, and it becomes noticeable from a common area, you will be asked to take action.
- Trees growing inside your patio area are your responsibility. Ensure that the tree is not interfering with the fence, the roof or your neighbor's area.
- Decorations and potted plants (including hanging plants and baskets) that are not maintained will be removed after the owner has been notified.
- Bird feeders are not allowed in the complex due to the damage that is caused when birds begin nesting in or around units. They also attract rodents and other wildlife.

Here are a few other considerations when planting or decorating your garden space.

- Please keep planters and pots to a minimum. A few planters add personality to your unit, but in excess they begin to look messy and unkempt.
- Keep garden decor to a minimum. Many garden decor items are not high quality and show signs of wear quickly, detracting from the appeal of our community.
- Please plant annuals and other plants as soon as possible after purchasing. Plants and flowers that remain in nursery containers in your garden area for extended periods of time will be removed.
